3. The following organizations have been given automatic PAC approval:
 - The American Stock Horse Association (ASHA)
 - American Competitive Trail Horse Association (ACTHA)
 - APHA Approved Regional Clubs (all-breed classes only)
4. The American Competitive Trail Horse Association (ACTHA) and Trail Challenge events under 12 miles will now be placed in the Trail category.
